CONDITIONS OF APPLICATIONS:

1. \$250.00 must accompany the application. Balance is payable on or before May 1st for all terms.
2. Refund of deposit for cancellation of application cannot be made after March 1. **No refund of the tuition balance paid shall be made after June 1** except under the following circumstances:
 - a. In cases of withdrawal during camp upon a camp doctor's order, in which event \$25.00 for each week remaining shall be refunded. The \$25.00 will be prorated for any portion of a week remaining.
 - b. In its sole discretion, Kickapoo Kamp may allow a refund in cases where a camper withdraws altogether no later than three weeks prior to the beginning of her term, provided that there is a substitute camper who is in all respects acceptable to Kickapoo Kamp, and who attends the term in the place of the original camper; and provided further, that no additional expense is incurred by Kickapoo Kamp with respect to the substitution.
3. No camper shall be accepted unless she is known personally by the Director or a Counselor, or in her sole discretion the Director determines based on references that the camper measures up to the standards of Kickapoo Kamp.
4. The Director reserves the right to dismiss any camper whose influence and/or conduct becomes in any way, in the Director's sole discretion, detrimental to the other members of camp, or who engages in behavior unacceptable under the generally accepted standards of the camp.

I approve the application above and the conditions listed here and in the catalog, and hereby certify that my child is of good moral character. She has permission to engage in all prescribed camp activities, except as noted on the application.
